Official Contest Rules

- 1. **Introduction**: These general contest rules listed below pertain to all station websites, social media accounts, services, content, partnerships, and promotions on Bold Gold Media Group physical, temporary, or virtual properties and its subsidiaries, including 98.3 WSUL FM, 95.9 VOS-FM, WDNB FM Thunder 102 and 104.5, Catskills News Talk 92.5, 94.9, WVOS 1240AM, Bold Gold Digital, RadioBold App, Amazon Alexa Skill(s), print media, media platforms, paper entry forms, internet entry forms, in-person events, radio call-in contests, online video or audio streaming, podcasts, third-party links, or any other AM/FM radio broadcast (hereby referred to as STATIONS), unless otherwise specified. Particular sweepstakes, contests, and promotions may have specific additional rules. Event venues, fulfillment partners, or associated third-party vendors may have additional rules, regulations, requirements, or restrictions. Specific rules will be disclosed in on-air announcements and displayed online on STATIONS websites.
- 2. **Eligibility:** Winners must be 18 years of age or older and have the right to use and access the email address used for entry. Employees of STATIONS, station advertisers, their advertising agencies, employees, and their immediate family members (including spouses and children) are not eligible to play, enter, participate, or win. Certain physical prizes must be picked up in person by winners at the time appointed by STATIONS at the STATIONS facility located at 198 Bridgeville Rd., Monticello, NY 12701, unless otherwise directed.
- 3. **Entry:** No purchase is necessary to enter any contest. Void where prohibited.
- 4. **Awarding Prizes:** Prizes will be awarded and are specific to the associated event, contest, or promotion. Event contests last from their official public start until all prizes are awarded. Events may have multiple public calls for entry on varying platforms. Entrants may only win and be awarded prizes once per event contest and are not eligible to re-enter the event contest throughout its duration. Official winners are limited to one winner per household throughout the length and duration of the event contest. Once a prize has been awarded, any members of the same household and any immediate family members are ineligible to win prizes, including passes, tickets, and vouchers, for the same sweepstakes, contest, event, or promotion. Once a winner is named and a prize has been awarded, any entries made by any members of the same household and immediate family members are voided. Once a prize has been awarded, the winning individual and any members of the same household and immediate family members are ineligible to enter any STATION event contest for 30 days. Violators may be subject to penalties pursuant to 47 U.S. Code § 509.
- 5. Claiming Prizes: Prizes must be claimed within 30 days of notification. Winners of certain events or concert tickets must claim electronically. Eligible winners must have the ability to access the email address used for entry to receive prizes. Winners may be subject to additional processes, rules, and requirements for electronic ticket delivery, including platform account creation, identity, and eligibility verification set forth by third-party vendors, event locations, venues, or web platforms. Event venues, organizers, or promoters reserve the right to limit, restrict, or revoke access. Failure to claim prizes in a timely manner constitutes forfeiture, and prizes become the property of STATIONS.
- 6. **Responsibilities and Liabilities:** Any difficulties affecting the winner's ability to claim prizes are not the responsibility of STATIONS, including the inability to receive notifications or instructions via email messages,, problems with telephone lines, internet access, passwords, unforeseen circumstances, utility service interruptions or outages, unreceived messages or communications, technical difficulties, transportation, weather conditions, scheduling, personal hardships, or accidental omissions. Winners will not hold STATIONS responsible for any taxes, injury, or expenses incurred while utilizing prizes.
- 7. **General Rules:** No substitutions for unclaimed or unwanted prizes will be available from STATIONS or the providing entity. Prizes may not be sold, transferred, traded, nor combined with other prizes. Violators of these rules will be banned from participation in any future STATION sweepstakes, contests, promotions, or events.
- 8. **Publicity:** By entering contests and giveaways, contestants acknowledge that STATIONS have the right to, without prior or further authorization, publicize their name, character likeness, photograph, voice recordings, and broadcast the fact that they are a winner for promotional purposes without financial remuneration.
- 9. **Odds and Legal Requirements**: The odds of winning is based on the number of entries received. If the total prize value exceeds \$5,000, the contest must be registered and bonded with the State of New York as required by law.
- 10. **Data Privacy:** STATIONS collect personal information you provide when entering our contest, such as name, email address, phone number, and mailing address, to administer the contest, contact and notify winners, award prizes, and comply with legal requirements. STATIONS do not share, sell, or rent your personal information to third parties except with service providers for contest administration, as required by law, or with your consent. STATIONS implement security measures to protect your personal information and retain it only as long as necessary for contest purposes or as required by law. STATIONS may update this policy at any time, with changes posted on our website and applicable to future entries. For questions or requests regarding your personal data, call us at (845)794-9898.
- 11. **Streaming Delays:** Due to the nature of STATIONS programming and content streamed on internet platforms, contests and promotions heard on the STATIONS may have time delays. Users of streaming internet platforms or apps may be at a disadvantage compared to entrants who participate by hearing the contest or promotion via conventional broadcast radio.
- 12. **Dispute Resolution:** Any disputes arising from the contest will be resolved through arbitration in accordance with the rules of the American Arbitration Association.
- 13. **Modifications:** By entering contests and giveaways, contestants agree to the rules of the contest or promotion and the decisions of the judges, which are final. STATIONS reserve the right to modify, change, or cancel the contest or promotion without notice.
- 14. **Agreement:** By participating in contests and giveaways, persons agree to all of the above and are bound by the decisions of STATIONS.
- 15. **Fraud:** The STATION prohibits any violation of these rules. Any attempts at forgery, impersonation, misrepresentation, intimidation, cheating, circumvention, or manipulation of contest entry or contest mechanisms, or preventing the fair participation of others will be considered fraud by the STATION and will be recommended for prosecution to the fullest extent of the law pursuant to 47 U.S. Code § 509.
